

Summer Settling-In Bonus: Terms & Conditions 2026

- **Eligibility:** This offer is exclusively available to **new children enrolling and commencing their attendance** at London Early Years Foundation (LEYF) during **July, August and September**. It does not apply to existing children or those re-enrolling after a break in attendance.
- **September Starters 2026** do not get a discount in October. ENROLMENT in September only gets up to £500 off)
- **Offer Benefit:** Eligible children will receive up to **£1000 total discount**, applied as £500 off each of the first two nursery invoices.
- **How it Works:** The discount will be credited to your account, reducing the first two invoices up to £500 each, provided the child attends a **minimum of 3 days per week**. If your bill is lower than £500 for the first month the deduction will be limited to the total amount of the invoice.
- **Session Structure:** The offer applies to children enrolled for at least 3 full days per week, based on their booked session pattern.
- **Minimum Enrolment:** A minimum of **3 full days per week** is required to qualify for the discount. Discount is only available for the months of July, August and September (So if you enrol in September, you do not get a discount in October. ENROLMENT in September only gets up to £500 off)
- **Non-Transferable & No Cash Value:** This offer has no cash alternative, is non-transferable, and cannot be exchanged for other services or discounts.
- **Maximum Discount:** The total discount applied will not result in a credit balance on your account. If the discount exceeds the total amount due on an invoice, the remaining discount value will be forfeited and cannot be refunded or carried over to subsequent months. The discount only applies for two consecutive months.
- **Limited Availability:** Enrolment is subject to availability. We recommend securing your child's space early due to anticipated high demand.
- **Withdrawal of Offer:** LEYF reserves the right to amend or withdraw this offer at any time without prior notice.
- **Standard Terms Apply:** All other standard LEYF terms and conditions of enrolment and attendance apply. You can find these on our website or request a copy from our nursery team.
- **Non-Transferable/No Cash Value:** The offer has no cash alternative, is non-transferable, and cannot be exchanged for other services or discounts. This promotion cannot be used in conjunction with any other discounts or promotions.
- **Charges:** Any additional charges are included. Extra sessions are not included.
